PURPOSE

To seek the Community and Culture Committee's support for Council endorsement of the recommendations for grant funding under the Community Grants Program for Round 1 of the 2015/16 financial year.

RECOMMENDATION

MOVED: SECONDED:

That it be recommended to Council that:

BACKGROUND

The Community Grants Program is a distribution of Council grant funding that supports the provision of programs, projects and events for the local community to participate in a wide range of recreational, cultural, community and environmental activities.

The Program has been in operation since 1979 and historically, has comprised two funding streams – Community Grants and Festivals and Events. Its purpose is to encourage active citizenship, community capacity building and to support community members to respond to local needs by providing assistance to individuals, community groups and organisations either through community projects, that provide a service or program, or festivals and events for residents of the City.

Following a review of the financial support provided to community-run events Council endorsed in June 2015 (Item 159/15) consolidation of the Festivals and Events component of the Community Grants Program into the new Community Event Sponsorship Program.

The Community Grants Program now comprises one funding stream for community grants with funding of up to \$4,000 available for a project or program that demonstrates benefit to the Unley community. An annual budget of \$62,500 for the Program was endorsed by Council for 2015/16 as part of the budget process.

Two funding rounds are offered each financial year in September and March.

DISCUSSION

For the September 2015 round, a total of 24 applications have been received requesting funding totalling \$86,575. This is a substantial increase of 11 applications for community grant funding in the corresponding period last year and for which the total funding requested was \$37,846.

An administrative working group comprising Council's Manager Community Development, Cultural Development Coordinator and Executive Assistant Community met on 14 October 2015 to assess the applications and to propose funding of the projects and programs as outlined in Attachment 1 to Item 9/15.

Attachment 1

All applications were assessed and ranked using the criteria outlined in the Guidelines (Attachments 2 to Item 9/15). A scoring system, consistent with the weighting of the criteria, produced a ranking for all projects and the ranking is then used to determine the levels of funding recommended, i.e. funding or partial funding.

A copy of the Community Grants applications, together with a summary of the Administration's recommendations for funding, is available in the Members Room.

COMMUNITY ENGAGEMENT

The Community Grants Program was advertised in the *Eastern Courier Messenger*, on the Council's web site, and at Council's community centres and libraries. Information was also circulated to a number of community organisations, individuals and community groups.

Informal sessions were offered to prospective applicants to assist with the preparation of submissions.

ANALYSIS OF OPTIONS

Option 1 – Community Grants and Festivals and Events Projects be funded as outlined in Attachment 1 to Item 9/15 and the applicants notified of the outcome of their application

This option will provide valuable support to Unley residents by providing programs, projects and activities that make a positive impact in the community.

Option 2 – Council may wish to make changes to the recommendations for funding

Council may wish to change the funding allocations to reflect alternate funding priorities. However, in making any changes, Council should consider the budget, the guidelines, existing policies and probity of decision making.

RECOMMENDED OPTION

Option 1 is the recommended option.

POLICY IMPLICATIONS

There are no significant policy implications with this decision and the recommendations are consistent with the Community Grants Program Policy. There is an allocation in the 2015/16 annual budget and business plan to cover the allocation of the grant funding.

CONCLUSION

Projects and activities supported by the grants program provide the opportunity for local community groups, individuals and organisations to make a positive impact on the local and wider community by meeting community needs and promoting lifelong leisure and learning opportunities. A significantly higher number of community grant applications were received this round, which may be attributed to increased promotion of the grant opportunity.

The Committee's recommendation to Council for endorsement of grant funding as outlined in Attachment 1 to Item 9/15 is sought.

Community Grants Program (Community Grants) **Guidelines – September 2015**



WHAT IS THE PURPOSE OF THE COMMUNITY GRANTS PROGRAM?

The purpose of the program is to encourage and support community projects that provide a service or program to residents of the City by fostering opportunities for individuals, community groups and organisations to access and participate in a wide range of activities and projects.

Grant funding of up to \$4,000 is available.

Funding is offered twice a year and, for the 2015/16 financial year, applications will close in **September 2015** and **March 2016**. The closing date for the September 2015 funding round is 30 September 2015.

Late applications will not be accepted.

WHO CAN APPLY?

Applications will be considered from *individuals, notfor-profit community groups and organisations. Applicant organisations do not need to be incorporated but must have a current bank account in the applicant organisation's name.

Individuals, community groups and organisations may only submit one application per funding round per funding stream.

Applicants must operate within the Unley local government area or proposing an activity that will take place within the Unley LGA.

*Individuals may only apply under the auspice of a not-for-profit community group or organisation.

WHAT FUNDING IS AVAILABLE?

You may apply for funding of up to \$4,000 in the areas of:

- Recreation (i.e. innovative community recreation and physical activity programs; new equipment, fitness programs new to Unley)
- Art and Culture (i.e. collaborative arts projects between artists and the community, cultural awareness programs, community art projects)
- Community (i.e. new initiatives and/or programs especially targeting disadvantaged or minority groups, learning and skill development, community health and safety programs, new equipment that increases the ability of a group to deliver a service or program to the wider community, promotion of healthy eating and access to healthy food)
- Environment (i.e. community garden projects, environmental awareness and education,

streetscape programs in partnership with Council, initiatives that reduce water and energy use, waste, minimise pollution or improve vegetation)

WHAT IS THE CRITERIA FOR FUNDING?

Your application must:

- Meet an identified recreation, cultural, community and/or environmental need in the City which is clearly defined and researched.
- Be of direct benefit to residents of the City of Unley.
- Encourage active citizenship and participation by the wider community.
- Have a clearly defined evaluation process.
- Show the ability to obtain additional resources if grant money forms only part of the funding needed. Resources could include fund raising, grants, volunteers, in kind support, use of existing funds, etc.

IF YOU ANSWER <u>YES</u> TO ANY OF THE FOLLOWING QUESTIONS, YOU ARE <u>NOT ELIGIBLE</u> TO APPLY.

Will the funding be used for:

- Ongoing salary or salaries (a position created for the length of the project is considered eligible) or associated day-to-day operational costs.
- Reimbursement of moneys already spent or for competitions, projects, programs or a purchase that have already been completed or costs that have already been incurred prior to 1 June 2015.
- Activities and purposes primarily associated with, and for the benefit of a commercial organisation.
- Renovations or capital works, defined as permanent improvements to a building or grounds that will increase its capital value.
- A purpose or purposes where the core funding responsibility normally rests with the State or Federal Government.

WHAT ELSE?

- All applications must be received on the Council approved Application Form and by the closing date
- Successful applicants must confirm their intention of accepting the grant and conditions by completing a Grant Acceptance Form, which must be received by Council before any grant funding is made.

- You are required to submit a Final Financial Acquittal Report within two months of the project completion. Receipts for purchases must be included. Any applicant not meeting this obligation could be ineligible for future financial support.
- As part of the grant acceptance process, you may be required to attend an evening function to celebrate all community grant funding and to share your project/event with other grant recipients.
- Any changes to the project expenditure must be submitted to Council in writing for approval.
- Successful applicants must acknowledge the City of Unley in any publications or publicity regarding the project.
- Council reserves the right to publish your organisation/club name on the City of Unley web site
- If your application is for purchases of \$500 and over, you must submit a minimum of two quotes with your application.
- In kind volunteer hours are to be calculated at \$27.45 per hour.
- Other in kind contributions can include donated materials; professional expertise; venue hire; other costs being absorbed by the organisation/club.

INSURANCE

All applicants should consider conducting a risk assessment process for their project to address any necessary insurance implications. Organisers should check their current insurance arrangements to determine if any extra cover is required.

WHAT HAPPENS TO MY APPLICATION?

- You will be sent a notification that your application has been received.
- Applications are assessed by a panel and final recommendations submitted to the Community and Culture Committee prior to presentation to the November 2015 Council meeting for final determination.
- You will be notified of the outcome of your application within one week of the November 2015 Council meeting.

- If your application is successful, the Grant
 Acceptance form must be completed and returned
 to Council before payment is made.
- The Council reserves the right to part-fund an application.

PURPOSE

To update the Community and Culture Committee on the progress of Involve Unley: Public Arts Strategy and seek preliminary ideas for proposed future activities for 2016/2017 budget planning.

BACKGROUND

The City of Unley has a rich history of creating public art in all of its temporary, ephemeral and permanent forms over many years. Many of these projects have arisen due to programs, projects and spaces that have been identified as part of other wider infrastructure projects, festivals and other events.

DISCUSSION

Public Arts Strategy

At its meeting in May 2014 Council (Item 1139/24) Council endorsed Involve Unley: Public Arts Strategy and Public Arts Policy. This can be found on the Council's website http://www.unley.sa.gov.au/CityOfUnley/media/CoU-Media-Library/community%20and%20culture/Arts%20and%20Culture/Public-Arts-Strategy.pdf.

Our Public Arts Strategy provides a clear direction on how public arts can be encouraged, conceived, created, implemented, valued and championed in the City of Unley over five years.

This Strategy moves our thinking from a single definition of public art. There are multiple art forms and styles which can be considered, individually or in combination, when exploring the creative expression of our culture in the public realm. Examples of these could be visual, sculptural, digital, oral, written and performance art practices produced on an ephemeral, temporary or permanent basis, hence the title of the Public Arts Strategy.

The Public Arts Strategy provides a discussion on the potential role of public arts in Unley and how art can act as a reflection and celebration of our local culture. The Strategy reflects that the community needs to be an active and engaged part of any public arts process and also that the primary inspiration and content of future public arts can draw upon local heritage, stories, artists, materials, manufacturers, producers, geography, diverse communities and their identity and sense of place.

In order to achieve popular and quality public arts, the Strategy outlines a series of Guiding and Implementation Principles that will act as a checklist for the future of the aesthetic, viability and sustainability elements of public arts in the City of Unley. The Guiding Principles focus on engaging the community, fostering creativity, encouraging diversity, delivering artistic value and being relevant to new ideas and issues. The Implementation Principles focus on the operational, delivery and maintenance of future public arts including funding, partnering, commissioning processes, documentation, evaluation, maintenance and de-accession.

The Public Arts Strategy also contains a framework for projects and programs under various categories. This has been structured under a series of seven typologies which focus on opportunities to explore and generate artworks from

the small scale to the large over a five year period. This allows flexibility to test and adopt a broad ranging set of approaches and options in multiple locations. Some of the proposed typologies will require limited funding and others will require either external partnerships and/or funding. Some of the recommended actions propose short term, pilot and quick response works or events. Others suggest a series of stages leading to more permanent, large scale sculptural pieces.

The Public Arts Strategy recommends pilot projects in each of the typologies that can act as a catalyst for further discussion, refinement and implementation. It should be acknowledged all future projects will take time to evolve through a variety of engagement techniques and professional procedures as is the case in good community cultural development. Therefore, each project will be developed in a unique way.

The Strategy also contains the Public Arts Policy, local and global case studies and a bibliography.

Public Arts Projects Year 1

Following this endorsement, \$20,000 was allocated in the Annual Business Plan 2014/2015 for the first year of public arts projects. The purpose of the first year was to test and experiment with temporary public arts to educate, inform, facilitate and collaborate in a new way of engaging with our community through the expression of the arts. Diverse art forms were used to bring our public realm alive. The following projects were completed:

linger, longer

linger, longer was an investigative and experiential temporary public arts project re-examining our place in space. What makes us linger, longer? What do we want in our public spaces?

Undertaken over one week in April 2015 at various locations around Goodwood, Parkside and Unley, artists came to engage the Unley community in interactive experiences in our public realm. The artists creatively asked the community personal and placemaking questions, interacted with the community and showed how spaces could be reactivated and re-configured.

This project was created in conjunction with Open Space arts organisation and various professional dancers, movement artists, actors and musicians. Documentation of this project can be found at http://www.unley.sa.gov.au/community-culture/arts-culture

Found, out – Unearthing our place

Found, out was also an investigative and experiential temporary public arts project re-discovering and re-connecting with our local parks and reserves.

Undertaken over two weekends in May at Soutar Park and Everard Park Reserve, local people came together as artists and explorers with professional artists to work together to conceive, contribute and slowly transform the park with collective sculptures. Using the medium of clay and found flora from gardens, parks and reserves, people created their own work and placed them in their favourite places. The Water Tanks exhibition

Both of these projects were documented by photographer Ben Searcy and, in the spirit of putting more art in the public realm, the intention is always to give the projects more life by making art out of the documentation. As a result, the water tanks act as a moving gallery to be moved every 2-3 months around different locations in our Council area. At the end of 12 months new 'skins' will be devised which tell the story of our projects being undertaken in 2015/2016 and then they will head off a new tour. Currently the water tanks are located in front of the Unley Library. The documentation on the water tanks directs the community to find out more about these projects online.

Public Art Audit

A recommendation form the Public Arts Strategy was to undertake a Public Art audit across the whole Council area. This was initiated in June 2014 and completed by the end of 2014. Nearly 70 artworks commissioned by Council over many years were assessed by Greg Healey from Ground Play. These artworks range from sculptural pieces, benches, drinking fountains, murals, stobie poles and paving inlays. The assessments focused on the asset's condition and recommendations for future actions. The audit also made recommendations to place these artworks on our asset lists and establish future budgets to both maintain and upgrade our existing artworks. These recommendations are likely to be included in future work plans.

Public Arts Projects Year 2 (Current year)

Council approved \$45,000 in the Annual Business Plan 2015/ 2016 for the second year of public arts projects connected to the Public Arts Strategy. Three projects are currently in development:

All Connections to Unley

This project sits in the Ro-Ra-Ru typology of the Public Arts Strategy This project will ask the community what their connection with the City of Unley is, was or could be. As participants, All Connections to Unley will allow an unlimited amount of young, emerging, amateur and professional artists to

respond creatively to this theme to have their 2D artworks selected for display in the Council's main gallery and on Council infrastructure.

The project has two elements:

- An art prize competition in three age categories with an exhibition for the finalists at the Hughes Gallery, Fullarton Park Community Centre in May 2016. Details of the art prize will be released to the wider community in November 2015.
- Reproduction of the three winners' artworks to be displayed on the side
 of Council bins on our main streets. A limited edition of stickers will be
 produced for residents to display on their Council bins similar to the 40
 slow down campaign set up 10 years ago. These displays will achieve
 putting more artwork in the public realm and use existing Council
 infrastructure.

Emerging Art Walls

There has been an appetite in recent years by both the community and Elected Members to create more murals around our City. We have commissioned two murals and local shops have also created murals on the side of their businesses to identify suitable walls for murals. There have also been some guerrilla murals in the area. This project sits between the Tempo and Centrepiece typologies of the Public Arts Strategy.

Initially a public blank walls audit will be conducted by Council to engage the community, traders and Elected Members. A public campaign will invite submissions to be considered for artworks. Information will be requested such as: location, photo, reason for artwork, potential theme. A short list will be developed with key staff based on various external and financial conditions. This audit will be open by November 2015.

Artists will be asked to tender for this project. Four artworks will be created with a mixture of up to two commissions and up to two including community participation. The artworks will be led by a range of artists which could lead to different styles. The artworks could be spray can or paint.

Exact timing of the commissions is still being negotiated. One is aimed to be in the lead up to Fringe Festival and in association with a local Fringe venue.

Tempo and Flora (A reprise)

Building on the success of the temporary art projects from Year 1, elements of *linger, longer* and *Found, out* will be used to complement other place making projects in the next nine months such as Goodwood Road Upgrade and our major events.

These projects sit in the Tempo and Flora typologies of the Public Arts Strategy.

Four Elements

The Four Elements artworks are located on the Village Green and were commissioned in late 1980/early 1981. Over time various parts of the artworks have deteriorated in their structural condition. Four Elements are an iconic public art work in Unley and are popular both for their meaning and for play and appreciation by children and their families.

Four Elements were given careful consideration during the Public Art audit as there has been much discussion among Elected Members, staff and the wider community about its future given its deterioration and also the different aspect of its location with the new Village Green Plaza. An independent assessment by three of South Australia's leading public artists provided recommendations for an upgrade of the artworks.

Council approved a budget of \$25,000 for this project in the Annual Business Plan 2015/2016. A brief will be developed and distributed through Arts SA Public Art register, as per normal Council (and other councils') practice. The brief will focus on a re-invention and rejuvenation of the artworks and the immediate surrounding space. It will also re-emphasise the need to retain the integrity of the original artworks. It is anticipated all work will be completed by June 2016.

Documentation

Similar to Year 1, all projects will be professionally documented. Community members will be invited to self-document and self-publish to the Have Your Say Unley platform and the Involve Unley gallery on the Arts and Culture page of the Unley website. Photos will be re-designed on new skins for our touring water tanks exhibition from August 2016.

Community Engagement

The by-line of "Involve Unley" is integral in the philosophy of who owns art in the public realm and recognises the importance of engaging our many stakeholders. Both the development of our projects and the feedback we received were critical in the Council understanding both the debate and aspirations around art and its function in public spaces. The projects undertaken in Year 1 gave us insight to people's aspirations for vibrant and inclusive spaces both at particular locations and in general. It also provided feedback on what works and what does not work at particular times, in particular spaces with particular people. Overall it continues to inform a framework for a richer landscape with art at its heart. This feedback will be useful not only in the development further public arts projects but also for future Council decisions in the public realm.

Into the Future

The Public Arts Implementation Plan from the Public Arts Strategy will act as a major guide for the development of public arts projects for July 2016 and beyond. Consideration will be made of other opportunities as they arise both internally and externally to the organisation. Community engagement and our commitment to working with different typologies will guide Council's future decision making. As per the Public Arts Strategy, Year 3 promises to be another exciting program with \$ 61 000 bookmarked for public arts initiatives. Staff are looking forward to discussing these opportunities with Elected members, the community and Committee Members as part of the 2016/ 2017 budget deliberations.

PURPOSE

To seek the Community and Culture Committee's input and feedback into the future *Unley in Harmony* program.

BACKGROUND

The underlying philosophy of Harmony Day is to embrace diversity and respect our cultural, racial and religious differences. Harmony Day is a national annual event celebrated by Australians during March and has been enthusiastically supported by the City of Unley since 2006.

Between 2006 – 2010 Harmony Day was organised by the Office of the Mayor. The event was by invitation only and the general public was not included. In 2006 the event location shifted from the Town Hall to the Goodwood Library.

In July 2010 a review of Harmony Day activities was conducted and two key areas for change were identified:

- Shift in focus from entertainment value to educational significance
- Inclusion of the general public in the event

In 2011, our Harmony Day celebrations were revitalised to ensure increased opportunities for meaningful and positive connections that foster and encourage a more inclusive community. The *Unley in Harmony* program was developed and now consists of:

- A main event usually held at Goodwood Library
- Educational program through satellite activities (workshops, classes, demonstrations and performances targeting children and adult audiences)

To ensure greater diversity, the annual program is themed. Themes are usually based on the top 20 birth places of our residents, although other strategic opportunities are also considered as relevant.

Attached is an overview of themes and activities since 2011 (Attachment 1 to Item 10/2015).

Attachment 1

DISCUSSION

The 2016 event will be held on Friday, 4 March 2016. The cultural theme for this event is Italy, as Italians represent the fifth largest ethnic group in Unley. It is therefore quite appropriate to focus on Italian heritage and influence in the City of Unley.

The main event is titled *Italian Café* and is planned to be held at the Goodwood Library, transforming the car park into a piazza, complemented by a wood fire pizza caterer, live music and string lights. As usual, the program will include a keynote speaker, potentially Laura Cassai, winner of Masterchef 2014 or a Migration Museum Educator speaking about the contribution the Italian community has made to Adelaide and Unley.

Satellite activities could include an Italian themed BabyTime and StoryTime, Italian travel classes and/or a travel agent speaking about travel in Italy. We may also book Laura Cassai to run an Italian cooking class for our community.

The budget of \$5,000 is proposed to be carefully split between the main event (70%) and satellite activities (30%). The small budget only allows for modest catering and entertainment for up to 100 people at the main event.

Generally, the guest list will consist of a maximum of 30 invited guests such as community groups and VIPs (as selected by the Mayor) with the remainder consisting of Unley community members. General public invitations are sent out in the media, social media and hard copy in libraries and community centres. Due to budget and venue restrictions, the number of guests is controlled via RSVPs.

What is next?

The *Unley in Harmony* program is based on the principles of social and cultural inclusiveness and the underlying basis of tolerance and goodwill to others. Potential future themes could include South Korean, German and Nepalese and the current program format can fairly easily be adapted for each.

Alternatively, it is opportune to consider whether the program format meets the expectations of all our stakeholders (community groups, general community, Council, etc.). Transcultural competence involves more than recognising and respecting cultural differences. It also involves awareness, understanding and creating opportunities to breakdown underlying prejudice and racism.

There is opportunity to further build on our *Unley in Harmony* program and transform it into a comprehensive cultural awareness program by also focusing on contemporary and sometimes challenging subject matter that our community is often bombarded with in the media.

The 'Unley in Harmony' program has the potential to become a platform for targeted cultural exchange that may well assist in building mutual respect and cultural tolerance, and actively support:

- Our community's understanding of challenging culturally-related issues, and how they respond and relate to these issues.
- Becoming more culturally sensitive and reducing misunderstandings and conflict through misconceptions and stereotypes that may exist about a particular culture.

It is worthwhile to consider the future format of the *Unley in Harmony* program now to enable careful planning and budget considerations if changes are proposed for the 2016/17 financial year.
