# ITEM 999 QUESTION ON NOTICE FROM COUNCILLOR BOISVERT RE NUMBER OF TREES REPLACED WHEN DAP OR PLANNING APPROVAL TAKES PLACE

The following Question Without Notice was received from Councillor Boisvert at the October meeting of Council and the answer is provided below:

### **Question**

When the DAP or planning approve the removal of a regulated or significant tree they also condition the approval regarding the number of trees that must be replaced (to the satisfaction of Council). How is Council recording this information to ensure that each property can be followed up to ensure the survival of each tree and will this be recorded as an encumbrance when the property is sold?

#### <u>Answer</u>

Since the relevant legislative changes came into effect in late2011, Council administration has maintained a replacement tree register for circumstances where a development application for removal of a regulated/significant tree contains a planning condition that requires replacement trees to be planted. This condition requires the replacement tree/s to be planted with 12 months of the date of the development approval and for Council to be notified once the replacement trees have been planted. To date there have been few circumstances where Council has been notified that replacement trees have been planted. Councils only enforcement avenue relates to enforcing the conditions of the development approval. This can be time consuming and potentially expensive if Court action is required. Administration intend to put in place a program of random inspections to assist with compliance.

Administration do not consider that Council can legally require for an encumbrance of this nature to be registered on the title. The development application and condition will appear on the Vendors Section 7 statement at the time of sale of the property and this is considered to provide an appropriate mechanism to alert prospective purchasers of the existence of these requirements.
