KING WILLIAM ROAD TRADERS ASSOCIATION FASHION EVENT PROPOSAL 2013 – 'VARIETY ON KING WILLIAM'

That:

- 1. The report be received.
- 2. The UBED Commttee recommend to Council that;
- 2.1 The 'Variety on King William' event be declared as an event under section 33(1) of the Road Traffic Act.
- 2.2 A temporary road closure for King William Road between Mitchell / Park St and Thomas St from 10pm Thursday 17 October to 12am Saturday 19 October 2013 be endorsed.
- 2.3 Up to \$8 200 support for costs associated with the road closure be provided for the King William Road Traders Association should it be required.
- 2.4 Temporary Road closure fees and banner installation fees (as scheduled in the fees and charges schedule) for the event be waived.
- 2.5 A similar scale road closure and support of the same level from Council for proposed future events in 2014 and 2015, based on the Variety on King William event, be considered as part of the 2014-15 budget deliberations.
- 2.6 The King William Road Traders Association provide an event risk assessment and management plan to Council before 27 September 2013.
- 2.7 The King William Road Traders Association be advised of Council's decision.
- 2.8 The City of Unley provide \$10 000 corporate sponsorship as outlined in attachment 1 page 5 'sponsorship package benefits' in addition, promotion of The 2014 Unley Gourmet Gala event in suitable media opportunities.
