ITEM 629 QUESTIONS ON NOTICE FROM COUNCILLOR SALAMAN RE UNLEY **ROAD UPGRADE**

The following Questions on Notice were received from Councillor Salaman and were included in the February Council Agenda, and the answers are provided...

The attached report to Council and resolution passed by Council in February 2003 relates to the so called "Unley Road Upgrade" which was all set to proceed until the change of Government in 2003. At the time it was scuttled by the Government or the Department by withdrawing funding. I now ask:

1. Is the completion of the Unley Road Upgrade and associated works still a Council policy?

Answer

While there is no formal Council Policy on this issue, the Council at its meeting held 28 August 2000, endorsed the Concept Plan for the development of Unley Road with the outcomes of the consultation process being the subject of a future report to Council.

The City of Unley's Integrated Transport Strategy, endorsed by Council at its meeting held on 16 December 2002, recommended desired outcomes for the transport corridors (which included Unley Road).

2. How much had Council contributed to the project up until the time of its shelving?

Answer

The City of Unley has contributed \$864,000 towards the cost of undergrounding. There was a commitment of \$50,000 for the Rugby Street Bicycle Route but this amount was not expended.

3. Were any costings of the works on Unley Road, ever undertaken, and if so what were they?

Answer

The estimated costs for the project were as follows:

 Undergrounding \$3,537,500 Reseal \$605,812 Line marking \$23,299 Pedestrian Refuges \$42,300 • Rugby Bicycle Route \$299,800

Total Cost \$4,508,711

Additional items identified by the City of Unley in 2003 were the upgrade of local stormwater between Arthur Street and Culvert Street, estimated to be \$750,000. It was also identified that approximately 70% of the kerb and gutter on Unley Road was in need of replacement over the next few years at an estimated cost of \$1 million (2003 figures).

4. Were any costings of the works on the associated Rugby Street bikeway, ever undertaken, and if so what were they?

Answer

Two costings for this project have been found. One was \$299,800 referred to in a report to Council of the Unley Road Transport Working Group - Progress Report in August 2000 (Item 29).

A report prepared by Dorrestyn & Co. in 1999, entitled Unley Road Cyclists" Bypass Route estimated the cost as \$370,000 (in 1999 figures). This was subsequently referred to in a letter to Transport SA from the City of Unley's City Manager (see answer to question 8).

5. Was the undergrounding of the power lines on Unley Road a mandatory preliminary to the Unley Road Upgrade?

Answer

The undergrounding of the power supply was in accordance with the Power Line Environment Committee's Metropolitan Main Roads Program that aims to focus undergrounding priorities on the arterial roads. The work was undertaken in three stages as follows:

Stage 1 – Edmund Avenue to Marlborough Street

Stage 2 - Marlborough Street to Cross Road

Stage 3 - Greenhill Road to Oxford Terrace

The undergrounding of the power supply was undertaken as a precursor to the upgrading of Unley Road. The upgrade was not necessarily conditional upon it.

6. What was the total cost of the undergrounding, and how much was the City of Unley's share?

Answer

Total cost approx \$3,537,500 of which the City of Unley contributed \$864,000 (source: Item 376 Undergrounding of Power Lines – Unley Road March 2000). Transport SA contributed \$892,500 with the remaining provided by the Power Line Environment Committee (PLEC).

7. How was the Unley Road Upgrade to be funded, and how much was the Council's share?

Answer

The total project cost was \$4,508,711 of which \$3,537,500 was the cost of undergrounding and \$299,800 the estimated cost of the Rugby Street Route leaving \$671,411 for the reseal and line marking of Unley Road. No allowance was made for any alterations to existing traffic signals or new installations.

The City of Unley's commitment was \$864,000 for undergrounding and \$50,000 for the Rugby Street Route.

8. How was the Rugby Street Bikeway to be funded, and how much was the Council's share?

Answer

A letter to Transport SA from the City of Unley's City Manager dated 21 June 2000, undertook to commit \$50,000 in principle. Transport SA would contribute approximately \$200,000 for the following:

- Installation of a mini roundabout at Frederick and Rugby Streets
- Installation of a roundabout at Oxford Terrace and Rugby Street
- Upgrade of Haslop Reserve at Cremorne and Rugby Streets
- Installation of traffic signals at Wattle and Rugby Streets
- 9. Has Council actively lobbied the State Government to reinstate the funding so the project can be completed?

Answer

Letters were written to Premier Rann in February 2003 that included the resolution of Council from its meeting held on 24 February 2003 and to the Minister for Transport (Michael Wright) in December 2003.

A letter dated 28 January 2010, was sent to the current Minister for Transport requesting an update on where Unley Road sits in the State Government's current programme. An acknowledgement, dated 15 February 2010, was received from the Minister's office advising that the matter was being investigated and a response will be provided in due course.

10. With the coming State (and Federal) election looming, how can funding best be sought?

Answer

The City of Unley could consider developing a Corridor Management Plan for Unley Road that reflects the strategic directions identified in the 30 Year Plan for Greater Adelaide and the City of Unley's Development Plan Amendments. The Corridor Management Plan would be able to use the earlier work undertaken on the upgrade of Unley Road as a basis.

11. For the benefit of Members who are unaware of the history of this project, can the agenda and minutes extracts of 24 February 2003 please be appended to the answers to these questions?

ITEM 630 QUESTIONS ON NOTICE FROM COUNCILLOR CLYNE RE RELOCATION OF ENTRY ROAD ONTO TABOR LAND

The following Questions on Notice were received from Councillor Clyne and the answers are provided below. Background information is provided in the attachment.

- 1. Considering Council made a resolution in June 2008 to continue negotiations with Tabor Adelaide on the subject of potentially relocating the entry road onto Tabor land:
 - a. How many times have Tabor Adelaide and Unley Council met to negotiate the possible relocation of the entry road onto Tabor land after the resolution of Council (CSP 16 Jun3 '08 Item 131 (4)) which specifically directed such negotiations to occur?

Answer

There is not a record of how many times Tabor Adelaide and Unley Council met to negotiate.

Further information

However in order to provide answers to these questions a search of Council, Reports, Agendas, Minutes and other records was undertaken this week. In addition Tabor College has been contacted to confirm the order of events and correspondence exchange. Confirmation of correspondence exchange is anticipated for Friday 19 March 2010.

The search of records and discussions with Tabor indicate negotiations about the potential road relocation occurred commencing November 2007 and concluding in December 2008.

It is also clear that the Answer provided to the Council by the Administration at its meeting on 22 February 2010 (Item 613, Q 10) was inaccurate. The following information represents a more considered and accurate response.

Correspondence regarding the negotiation has been located and appears to have been exchanged between Tabor and Council Administration on the following dates (subject to confirmation as above):

- o 23 January 2008
- o 3 April 2008
- Letter undated, received by Council on 3 December 2008
- o 4 November 2008
- o 30 December 2008

Elected Members were advised on the progress of these negotiations via the following:

- o CS&P Report Item 131/08 June 2008
- o Memo 21 January 2009
- o Workshop 4 February 2009
- o CS&P Report Item 205/09 April 2009

Council records indicate that negotiations continued until December 2008 at which time no agreement had been reach regarding this matter.

In the Memo to Elected Members of 21 January 2009 the following was reported:

"Recent negotiations with Tabor College have resulted in the Council Administration informing the College that it has decided to progress with detailed design of the concept Plan with the access road remaining in its current position. The decision has been necessary to allow sufficient time to seek external funding and ensure that the project is able to progress in a timely manner.

However, the college has also been informed the Council's preferred position is to continue negotiations in relation to the road relocation. Therefore, if at some time in the future Tabor College wishes to continue negotiations on the relocation of the road, the council will welcome the opportunity."

The purpose of the April 2009 Report was to seek endorsement to the Final amended Concept Plan so that detailed design work could be completed and the construction tender commenced. The Report included information about the conclusion of negotiations, at this time.

Discussions with Tabor following conclusion of the negotiations in December 2008 have related to the Administration seeking a financial contribution to the project from Tabor. No further negotiations have occurred regarding the relocation of the access road.

b. On what dates did the negotiations occur?

There is no record of the dates on which negotiations occurred. Correspondence listed above is the only record of negotiations.

c. Who was invited to the negotiations and who attended the meeting?

There is no documented record of any meetings held, in Council's records system.

It is understood that the following key people attended negotiations and corresponded on this matter:

- City of Unley, General Manager Urban Services (Council's negotiator)
- City of Unley, Open Space and Recreation Coordinator/s
- o Business Manager Tabor Adelaide (Tabor's negotiator)
- o Property Manager Tabor Adelaide.

d. Where are the minutes of these meetings?

There are no minutes on Council's records.

 - 10) What negotiations have occurred between Council and Tabor College to relocate the entry road onto their land?

And that the answer provided was:

- "...negotiations with Tabor College to relocate the road were conducted in 2008 and Tabor were unable at that time to commit to the use of their land to relocate the road."
- a) Why does the answer not indicate when in 2008 the negotiations occurred?

Answer

It was not interpreted that the question sought the dates on which negotiations occurred.

Please refer to previous Answers which it is hoped now satisfies this question (Q1. a & b)

b) Why does the answer not reference any of the negotiations which occurred in 2009 or 2010?

Answer

No negotiations occurred during 2009 and 2010.
