ITEM 748 QUESTIONS ON NOTICE FROM COUNCILLOR HUDSON RE GAP SALINITY

The following Questions on Notice have been received from Councillor Hudson and the answers are provided:

Questions

1. Can Council be re-assured that the level of salinity in GAP water is sufficiently low to ensure that its continued use will not have an adverse accumulative effect?

Answer:

In July 2009 the City of Unley engaged Turfwise Consulting to provide expert opinion as to the potential impacts of irrigation with GAP water on the turf and soils at Goodwood and Unley Ovals. This report together with the Recycled Water Management Plan (RWMP) provides assurance that concerns with the level of salt can be managed though controlled use of recycled water. The report and RWMP were tabled as Attachments 5 and 6 to the water supply for council reserves presented on the 21 September 2009.

2. Has Council received legal assurances that GAP water will not be injurious to Unley's trees and grassed and vegetated areas?

Answer:

It is understood that no legal assurance has been received, however, it is noted that SA Water has an obligation to supply recycled water at a quality that is defined as fit for "Unrestricted Municipal Use".

3. What levels of salinity have been predicted in GAP water?

Answer:

SA Water has provided test results for the Total Dissolved Solids from Feb 10 through to June 10. The readings varied between 930mg/L and 1000mg/L.

4. Is any research material available on the potentially adverse effect of prolonged use of GAP water?

Answer:

The GAP project has been in operation for a relatively short period of time. As such reports on its prolonged use are not readily available at this time. It is noted however that the report from Turfwise Consulting did investigate other areas where highly saline water is used on green spaces.

5. Does the Council contract on this matter address the question(s) of salinity?

Answer:

Legal documentation between SA Water and Department of Health and SA Water and Council require that the supply of recycled water cease if water quality standards associated with the licence are non complying.

6. In the event of GAP water reaching an unacceptable level of salinity, what recourse is available to Council under the contract?

Answer:

The current water supply agreements that all users of mains water have with SA Water does not guarantee a continuous supply. The GAP water may still be subject to the same interruptions due to breakdown, water quality or other issues.

The contract between SA Water and Council ensures availability to water is protected over the life of the contract. In particular, its minimum rights of supply will be until Council has recouped its investment through the savings associated with the use of recycled water.

7. If necessary, will an unsatisfactory answer to any one of these questions be the basis of a report to Council as a matter of extreme urgency?

Answer:

In the event of an unsatisfactory answer a report to Council can be produced at Council's request.

ITEM 749 QUESTION ON NOTICE FROM COUNCILLOR HEWITSON RE GAP WATER

The following Questions on Notice have been received from Councillor Hewitson and the answers are provided:

GAP Water

1. Given the recent heavy rain and full storages will we be able to water our parks with mains water without restriction this summer if the GAP water is not installed this summer?

Answer

Premier Rann announced on Sunday 29 August 2010 that Water Restrictions currently enforced in South Australia will be relaxed in most parts of the state to updated Permanent Water Conservation Measures (PWCM) on December 1, 2010. The Administration has been advised by the Water Conservation Coordinator of SA Water that the updated PWCM will be finalised and communicated to Councils prior to this date. The Administration has further been advised that the updated PWCM's are likely to allow greater flexibility in watering practices.

2. If there are restrictions what are they?

Answer

As outlined in the above answer, the Administration is yet to be advised to what extent the current water restrictions will be modified. The advise from SA Water is that as soon as the information is supplied to SA Water Council's will be notified of any change.

3. Has the administration given instruction to our engineering staff to build at least one of the two GAP schemes ASAP so that we can benefit from the 75% trade off for the water we do not consume from the mains?

<u>Answer</u>

SA Water have agreed in principle to manage the two pipeline legs separately and therefore we can lodge the drawings for the Unley leg now and lodge the drawings for the Goodwood leg when we have comments/approval from Australian Rail Track Corporation (ARTC) and TransAdelaide on the easements.

We can also proceed with the assembly of tender documents and the tender call for both legs using the draft documents with reasonable confidence that the drawings/specifications will be signed off by SA Water in due course. We would be able to proceed with the construction of Unley leg separately subject to receiving suitable tenders within budget for the whole project. 4. Previous staff now left indicated that the Unley Oval scheme would be the one with the greatest return and the quicker build. Is this still the case?

<u>Answer</u>

Yes.

Unley Oval has a high water use and its connection to GAP water is a high priority.

5. When can we expect the first GAP water to flow onto our ovals and parks?

<u>Answer</u>

Whilst we will have a more accurate timeframe when tenders have been received it is anticipated that the Unley leg could be well advanced by April 2011. Sections of this leg are now tied to the Glen Osmond Creek Project as the GAP pipeline will be installed in conjunction with the culvert installation. We will have access to a tanker refill point in Victoria Park during summer and this GAP water will be available at our GAP contract price.

ITEM 750 QUESTION ON NOTICE FROM COUNCILLOR HEWITSON RE PLANNING DPA3 AND 2

The following Questions on Notice have been received from Councillor Hewitson and the answers are provided:

1. What strategic plans are there for Unley and Greenhill Roads for high density development?

Answer

Council's strategic plan entails protection of the majority of the heritage and character areas and the focussing of higher density development in suitable key precincts, and particularly the main road transit corridors, near public transport and existing services and facilities. Greenhill Road and Unley Road are prime corridors that lend themselves to higher density. To date, an urban design study has been undertaken of parts of Greenhill Road.

2. I was phoned up by the Messenger paper to ask about the high-rise development detailed plans along Unley Road. Why are we negotiating with the State Government without a coherent plan of our own that has been endorsed and approved by Council?

<u>Answer</u>

The Village Living and Desirable Neighbourhoods Development Plan Amendment (VL&DN DPA), endorsed by Council in 2008 with Stage 1 implemented in 2009, provides a coherent plan for accommodating growth and higher density development on Unley Road and other main road corridors. The State Government is keen to advance the policy change for key corridors particularly in the inner metropolitan area and Council is well placed with its work to continue the pursuit of the VL&DN DPA. Council has sought a partnership arrangement with the Department of Planning and Local Government for their assistance to facilitate the earlier conclusion of the necessary investigations and new policy development of Council's DPA.

3. Will we make public our planning to date to enable a coherent community discussion on the method of implementing State policy of increasing urban density close to the CBD?

<u>Answer</u>

The concept of higher density development on the corridors has been available to the public via VL&DN DPA. There is no other plan that has been developed for any of the road corridors. We are currently exploring the implications of the State's growth targets and as the desired design of higher density development evolves, and the details of the policy approach is resolved by Council, public consultation will occur.

4. Our admirable plans for the Keswick TOD have been discussed by the Elected Members, are they now available for public comment?

<u>Answer</u>

The Keswick Barracks and Surrounds Urban Design Framework initial scoping report was received by Council in October 2009. Work has continued on an extended framework area and further investigations are currently concluding to address the broader State Government Keswick/Wayville TOD proposal. This is expected to be available for Council consideration in October 2010, when its status and basis for consultation can also be considered.

5. Do we have a target date for our DPA2 and 3 being approved by Council and if so when is it?

Answer

The VL&DN DPA 2 (Residential) and VL&DN DPA 3A (Unley and Greenhill Roads) drafts are anticipated at this time to be available for Council consideration in mid 2011.
